private sector which do not depend on Govt. grants, but recover their costs from students in the form of fees. Some of these institutions had their origin in what was then known as "Capitation fee". Institutions which were set up by private agencies in response to the increasing social demand for professional and technical education, especially in medicine and engineering, most of them were charging exorbitant fees, and the facilities provided, in many cases, were much below the essential requirements. The central and state Govts. discourage this trend, and legislative measures are being envisaged to regulate the level of fees that could be charged. These have been legislations and the Supreme Court, dealing with a number of cases on the subject, has directed that the Govt. and its agencies should lay down the principles on the basis of which institutions could levy on.
